GIBRALTAR COINAGE ACT, 1990

ISSUE OF THE HOUSE OF WINDSOR COLLECTION COINS NOTICE 2023

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice—

Title and commencement.

1. This Notice may be cited as the Issue of the House of Windsor Collection, Coins Notice 2023 and comes into operation on the day of publication.

Issue of new coins.

2.(1) New coins of cupro nickel silver and gold in the denominations of a Quarter, Half, One, Double/Two and Five/Quintuple Sovereigns, Half Crown, One Crown and 1/25th Crowns shall be made.

(2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part II and VII of the Schedule to the Gibraltar Coinage Act, 1990.

(3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Parts of the Schedule.

Design of the coins.

3. The design of the coins authorised by this Notice shall be as follows –

- (a) the obverse design depicts the newly sculpted Raphael Maklouf effigy of King Charles III and the Latin inscription reading; ‘• CHARLES III • D • G • REX • F • D • GIBRALTAR •’, which reads as CHARLES III • BY THE GRACE OF GOD • DEFENDER OF THE FAITH • KING OF GIBRALTAR and includes the denomination and the year in which the coin is struck;
- (b) the obverse design depicts the newly sculpted Raphael Maklouf effigy of King Charles III and the year in which the coin is struck, with the Latin inscription reading; ‘• CHARLES III • DEI • GRA • REX • F • D • GIBRALTAR •’, which reads as CHARLES III • BY THE GRACE OF GOD • DEFENDER OF THE FAITH • KING OF GIBRALTAR. The Sovereign Obverse does not include a denominational value as it is determined by its size, weight, and diameter;

- (c) the reverse designs depict a portrait of George V. Sprigs of oak taken from the House of Windsor Crest surround the portrait. Below the portrait is St Edward's crown, and above the inscription has their name in Latin with the words; 'DEI GRATIA REX' or 'DEI GRATIA REGINA';
- (d) the reverse designs depict a portrait of Edward VIII. Sprigs of oak taken from the House of Windsor Crest surround the portrait. Below the portrait is St Edward's crown, and above the inscription has their name in Latin with the words 'DEI GRATIA REX' or 'DEI GRATIA REGINA';
- (e) the reverse designs depict a portrait of George VI. Sprigs of oak taken from the House of Windsor Crest surround the portrait. Below the portrait is St Edward's crown, and above the inscription has their name in Latin with the words; 'DEI GRATIA REX' or 'DEI GRATIA REGINA';
- (f) the reverse designs depict a portrait of Queen Elizabeth II. Sprigs of oak taken from the House of Windsor Crest surround the portrait. Below the portrait is St Edward's crown, and above the inscription has their name in Latin with the words; 'DEI GRATIA REX' or 'DEI GRATIA REGINA';
- (g) the reverse designs depict a portrait of King Charles III. Sprigs of oak taken from the House of Windsor Crest surround the portrait. Below the portrait is St Edward's crown, and above the inscription has their name in Latin with the words; 'DEI GRATIA REX' or 'DEI GRATIA REGINA';
- (h) this reverse design inspired by the House of Windsor crest and depicts Windsor castle surrounded by sprigs of oak and the coronation crown sits above. The inscription reads 'DIEU ET MON DROIT', which translates to 'GOD AND MY RIGHT', the motto of the British monarch.

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
