GIBRALTAR COINAGE ACT, 1990

ISSUE OF THE 2023 SEVEN SIGNATORIES COLLECTION COINS NOTICE 2023

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice—

Title and commencement.

1. This Notice may be cited as the Issue of the 2023 Seven Signatories Collection, Coins Notice 2023 and comes into operation on the day of publication.

Issue of new coins.

- 2.(1) New coins of gold in the denominations of One Crown, 1/25 Crowns, 1/10 Crowns, 1/5 Crowns and Half Crowns shall be made.
- (2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part II of the Schedule to the Gibraltar Coinage Act, 1990.
- (3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

- 3. The design of the coins authorised by this Notice shall be as follows
 - (a) the obverse depicts the Gibraltar Coat of Arms with the inscription; GIBRALTAR, and MONTIS INSIGNIA CALPE and includes the denomination and the year in which the coin is struck;
 - (b) the reverse design depicts THOMAS CLARKE, a signatory of the Irish proclamation, which was signed in 1916;
 - (c) the reverse design depicts SEAN Mac DIARMADA, a signatory of the Irish proclamation, which was signed in 1916;
 - (d) the reverse design depicts THOMAS MACDONAGH, a signatory of the Irish proclamation, which was signed in 1916;
 - (e) the reverse design depicts PADRAIG PEARSE, a signatory of the Irish proclamation, which was signed in 1916;

(f) the reverse design depicts EAMONN CEANNT, a signatory of the Irish proclamation, which was signed in 1916;

(g) the reverse design depicts JAMES CONNOLLY, a signatory of the Irish proclamation, which was signed in 1916;

(h) the reverse design depicts JOSEPH PLUNKETT, a signatory of the Irish proclamation, which was signed in 1916.

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
