GIBRALTAR COINAGE ACT 1990

ISSUE OF KING CHARLES, 1 YEAR ON COLLECTION - PART TWO - COINS NOTICE 2023

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice—

Title and commencement.

1. This Notice may be cited as the Issue of King Charles, 1 Year On Collection - Part Two - Coins Notice 2023 and shall come into operation on the day of publication.

Issue of new coins.

- 2.(1) New coins of Gold, Silver and Cupro Nickel in the denominations of 1/25 Crown, ½ Crown, One Crown, Two/Double Crowns, Ten Pounds, Twenty-Five Pounds, One Hundred Pounds, Quarter Sovereign, Half Sovereign, One Sovereign, Double Sovereigns and Quintuple Sovereigns shall be made.
- (2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Parts II, VII and IX of the Schedule to the Gibraltar Coinage Act, 1990.
- (3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Parts of the Schedule.

Design of the coins.

- 3. The design of the coins authorised by this Notice shall be as follows
 - (a) the crown and pound coins shall bear on the obverse impression the effigy of His Majesty King Charles III with the inscription "CHARLES III D.G. REX F.D. GIBRALTAR" bordering the top edge, date of the year and value below;
 - (b) the sovereign coins shall bear on the obverse impression the effigy of His Majesty King Charles III with the inscription "CHARLES III DEI GRA REX F.D. GIBRALTAR" bordering the top edge, date of the year below;

(c) the reverse impression shall bear the Crown Jewels. The background of the design shows the jewels in front of the iconic South Rose window at the entrance of Westminster Abbey. The inscription reads, "WE ARE HERE TO CROWN A

KING, WE CROWN A KING TO SERVE".

(d) the reverse impression shall bear the iconic window at the centre of Westminster Abbey and King Charles III's cypher features on top of the coronation chair. The inscription reads, "WE ARE HERE TO CROWN A KING, WE CROWN A KING

TO SERVE".

(e) the reverse impression shall bear the Crown Jewels. The background of the design shows the jewels looking up at the famous celling in the abbey. The inscription reads, "WE ARE HERE TO CROWN A KING, WE CROWN A KING TO

SERVE".

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
