## GIBRALTAR COINAGE ACT 1990

### ISSUE OF KING CHARLES, 1 YEAR ON COLLECTION COINS NOTICE 2023

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice—

#### **Title and commencement.**

1. This Notice may be cited as the Issue of King Charles, 1 Year On Collection Coins Notice 2023 and shall come into operation on the day of publication.

#### **Issue of new coins.**

2.(1) New coins of Gold, Silver and Cupro Nickel in the denominations of 1/25 Crown, ½ Crown, One Crown, Two/Double Crowns, Ten Pounds, Twenty-Five Pounds, One Hundred Pounds, Quarter Sovereign, Half Sovereign, One Sovereign, Double Sovereigns and Quintuple Sovereigns shall be made.

(2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Parts II, VII and IX of the Schedule to the Gibraltar Coinage Act, 1990.

(3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Parts of the Schedule.

#### **Design of the coins.**

3. The design of the coins authorised by this Notice shall be as follows –

- (a) the crown and pound coins shall bear on the obverse impression the effigy of His Majesty King Charles III with the inscription “CHARLES III D.G. REX F.D. GIBRALTAR” bordering the top edge, date of the year and value below;
- (b) the sovereign coins shall bear on the obverse impression the effigy of His Majesty King Charles III with the inscription “CHARLES III DEI GRA REX F.D. GIBRALTAR” bordering the top edge, date of the year below;

- (c) the reverse impression shall bear the clockface of Big Ben showing 3.10pm, the time Queen Elizabeth passed away and his Majesty, King Charles III officially became the new monarch. The design also features a portrait of Queen Elizabeth II.
- (d) the reverse impression shall bear Balmoral Castle, the place where Queen Elizabeth II passed away. The inscription reads “THE QUEEN DIED PEACEFULLY AT BALMORAL THIS AFTERNOON, THE KING AND QUEEN CONSORT WILL REMAIN AT BALMORAL THIS EVENING AND WILL RETURN TO LONDON TOMORROW”.
- (e) the reverse impression shall bear Buckingham Palace, with the flag flying at half-mast. The inscription reads, “MAY FLIGHTS OF ANGELS SING THEE TO THY REST”.
- (f) the reverse impression shall bear the clockface of Big Ben showing 11.00am, the time that King Charles III was formally proclaimed at the Accession Council, held at St. James’s Palace, which is also featured under the clock face.
- (g) the reverse impression shall bear The King Holding the Sovereigns’ Orb, Sceptre, and wearing St. Edward’s Crown with his coronation Regalia. In the background are the iconic windows and ceiling of Westminster Abbey. The Inscription reads, “LONG TO REIGN OVER US GOD SAVE THE KING”.

**Legal Tender.**

4. The said coins shall be current and legal tender in Gibraltar.
