GIBRALTAR COINAGE ACT, 1990

ISSUE OF THE WINSTON CHURCHILL: THE LIFE AND TIMES COLLECTION COINS NOTICE 2024

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice-

Title and commencement.

1. This Notice may be cited as the Issue of the Winston Churchill: The Life and Times Collection Coins Notice 2024 and comes into operation on the day of publication.

Issue of new coins.

2.(1) New coins of gold and silver in the denominations of One Crown, 1/25 Crown, $\frac{1}{2}$ Crown Two/Double Crowns, Quarter Sovereign, Half Sovereign, One Sovereign, Double Sovereigns, Quintuple Sovereigns, one pound and five pounds shall be made.

(2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part I, Part II, Part VII and Part IX of the Schedule to the Gibraltar Coinage Act, 1990.

(3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

3. The design of the coins authorised by this Notice shall be as follows –

- (a) the sovereign design depicts the newly sculpted Raphael Maklouf effigy of King Charles III and the year in which the coin is struck, with the Latin inscription reading "CHARLES III • DEI • GRA • REX • F • D • GIBRALTAR". The Sovereign Obverse does not include a denominational value as it is determined by its size, weight, and diameter;
- (b) the standard design depicts the newly sculpted Raphael Maklouf effigy of King Charles III and the Latin inscription reading "CHARLES III • D • G • REX • F • D • GIBRALTAR" and includes the denomination and the year in which the coin is struck.

(c) the reverse five designs each depict Sir Winston Churchill in a heraldic garter. Garters are added to a coat of arms upon knighthood, and each design features a laurel wreath which represents power, authority, and everlasting legacy. Each design feature's Churchill's hand in the iconic 'peace' sign, surround by images related to each of his titles. The gloved hand shaking Churchill's hand represents the image of Queen Elizabeth II knighting Winston Churchill.

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
