## **GIBRALTAR COINAGE ACT, 1990**

### ISSUE OF THE 2025 REMEMBERANCE COLLECTION COIN NOTICE 2025

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice—

#### Title and commencement.

1. This Notice may be cited as the Issue of the 2025 Remembrance Collection Coin Notice 2025 and shall come into operation on the day of publication.

#### Issue of new coins.

- 2.(1) New coins of Cupro-Nickel and Gold in the denominations of One Crown, Eighth Sovereign, Quarter Sovereign, Half Sovereign, One Sovereign, Double Sovereign and Quintuple Sovereign shall be made.
- (2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Parts II and VII of the Schedule to the Gibraltar Coinage Act, 1990.
- (3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

# Design of the coins.

- 3. The design of the coins authorised by this Notice shall be as follows
  - (a) the coins shall bear on the obverse impression the effigy of His Majesty King Charles III with the inscription; "• CHARLES III D G REX F D GIBRALTAR •" and includes the denomination and the date of year;
  - (b) the sovereign shall bear on the obverse impression the effigy of His Majesty King Charles III with the inscription, "• CHARLES III DEI GRA REX F D GIBRALTAR •" and the date of year;
  - (c) the one crown coins shall bear on the reverse impression a wreath of poppies with barbed wire around the wreath. Also depicted is a wooden cross and plaque that reads "LEST WE FORGET" together with "REMEMBER THEIR SERVICE AND SACRIFICE" boarding the edge;

- (d) the sovereign coins shall bear on the reverse impression a wreath of poppies with an inscription that reads "LEST WE FORGET" in the centre;
- (e) the sovereign coins shall bear on the reverse impression of a female RAF veteran and solider reuniting with their child. Also depicted is a poppy in the lower right corner. The inscription reads "REMEMBER THEIR SERVICE AND SACRIFICE" boarding the edge;
- (f) the sovereign coins shall bear on the reverse impression of two hands shaking and solders walking through a barren landscape with a helicopter above. Also depicted is a poppy between the two hands shaking. The inscription reads "REMEMBER THEIR SERVICE AND SACRIFICE" boarding the edge;
- (g) the sovereign coins shall bear on the reverse impression different generations of servicemen together with a beret, poppy and Royal Navy ship. The inscription reads "REMEMBER THEIR SERVICE AND SACRIFICE" boarding the edge;
- (h) the sovereign coins shall bear on the reverse impression of a lone soldier kneeling at a comrade's grave. Also depicted is a globe with the mountain ranges of Afghanistan and a poppy in the lower left edge. The inscription reads "REMEMBER THEIR SERVICE AND SACRIFICE" boarding the edge;
- (i) the sovereign coins shall bear on the reverse impression of veterans raising a toast to a lost friend. Also depicted in the background is the graves at the Falkland's war memorial and a poppy in the lower left corner. The inscription reads "REMEMBER THEIR SERVICE AND SACRIFICE" boarding the edge.

# Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
