## **GIBRALTAR COINAGE ACT, 1990**

### **ISSUE OF THE GIBRALTAR CIRCULATING COINS – 100<sup>TH</sup> ANNIVERSARY OF QUEEN ELIZABETH II COLLECTION COIN NOTICE 2026**

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice—

#### **Title.**

1. This Notice may be cited as the Issue of the Gibraltar Circulating Coins – 100<sup>th</sup> Anniversary of Queen Elizabeth II Collection Coin Notice 2026.

#### **Commencement.**

2. This Notice comes into operation on the day of publication.

#### **Issue of new coins.**

3.(1) New coins of copper plated steel, nickel plated steel, cupro-nickel, mixed metal and alpaca in the denominations of one, two, five, ten, twenty, fifty pence, one pound, two pounds and five pounds shall be made.

(2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part I of the Schedule to the Gibraltar Coinage Act, 1990.

(3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

#### **Design of the coins.**

4. The design of the coins authorised by this Notice shall be as follows –

- (a) The obverse design depicts the effigy of King Charles III, the denomination and the year in which the coin is struck, with the inscription reading; “CHARLES III • KING OF GIBRALTAR”;
- (b) The reverse impression of the one pence and one pound shall depict an unseen effigy of Queen Elizabeth II during the years 1952 – 1962 and features the

inscription: “100 YEARS SINCE THE BIRTH OF OUR BELOVED QUEEN • 1926 - 2026”;

- (c) The reverse impression of the two pence and one pound shall depict an unseen effigy of Queen Elizabeth II during the years 1962 – 1972 and features the inscription: “100 YEARS SINCE THE BIRTH OF OUR BELOVED QUEEN • 1926 - 2026”;
- (d) The reverse impression of the five pence and one pound shall depict an unseen effigy of Queen Elizabeth II during the years 1972 – 1982 and features the inscription: “100 YEARS SINCE THE BIRTH OF OUR BELOVED QUEEN • 1926 - 2026”;
- (e) The reverse impression of the ten pence and one pound shall depict an unseen effigy of Queen Elizabeth II during the years 1982 – 1992 and features the inscription: “100 YEARS SINCE THE BIRTH OF OUR BELOVED QUEEN • 1926 - 2026”;
- (f) The reverse impression of the twenty pence and one pound shall depict an unseen effigy of Queen Elizabeth II during the years 1992 – 2002 and features the inscription: “100 YEARS SINCE THE BIRTH OF OUR BELOVED QUEEN • 1926 - 2026”;
- (g) The reverse impression of the fifty pence and one pound shall depict an unseen effigy of Queen Elizabeth II during the years 2002 – 2012 and features the inscription: “100 YEARS SINCE THE BIRTH OF OUR BELOVED QUEEN • 1926 - 2026”;
- (h) The reverse impression of the one pound shall depict an unseen effigy of Queen Elizabeth II during the years 2012 – 2022 and features the inscription: “100 YEARS SINCE THE BIRTH OF OUR BELOVED QUEEN • 1926 - 2026”;
- (i) The reverse impression of the two pounds and five pounds shall depict all seven unseen effigies of Queen Elizabeth II from 1952 – 2022 encircling her Royal Cypher and the signature of Raphael Maklouf and features the inscription: “100 YEARS SINCE THE BIRTH OF OUR BELOVED QUEEN • 1926 - 2026”.

**Legal tender.**

5. The said coins shall be current and legal tender in Gibraltar.
