## GIBRALTAR PILOTAGE ACT 2016

### GIBRALTAR PILOTAGE (AMENDMENT) REGULATIONS 2021

In exercise of the powers conferred on him by section 30 of the Gibraltar Pilotage Act 2016 and all other enabling powers the Minister has made the following Regulations—

#### Title and commencement.

1. These Regulations may be cited as the Gibraltar Pilotage (Amendment) Regulations 2021 and come into operation on the 1st April 2021.

#### Amendments to the Gibraltar Pilotage Regulations 2016.

2. The Gibraltar Pilotage Regulations 2016 are amended by—

(a) substituting the following Schedule for Schedule 6—
