GIBRALTAR PILOTAGE ACT 2016

GIBRALTAR PILOTAGE (AMENDMENT) REGULATIONS 2024

In exercise of the powers conferred on her by section 30 of the Gibraltar Pilotage Act 2016 and all other enabling powers the Minister has made the following Regulations—

Title.

1. These Regulations may be cited as the Gibraltar Pilotage (Amendment) Regulations 2024.

Commencement.

2. These Regulations come into operation on the 1st April 2024.

Amendments to the Gibraltar Pilotage Regulations 2016.

3. The Gibraltar Pilotage Regulations 2016 are amended as follows-

EXPLANATORY MEMORANDUM

These Regulations amend the Gibraltar Pilotage Regulations 2016 in order to effect annual review of pilotage fees and the boarding, landing and other charges under regulations 27 and 28.
