GIBRALTAR PILOTAGE ACT 2016

GIBRALTAR PILOTAGE (AMENDMENT) REGULATIONS 2026

In exercise of the powers conferred on her by section 30 of the Gibraltar Pilotage Act 2016, the Minister has made the following Regulations -

Title.

1. These Regulations may be cited as the Gibraltar Pilotage (Amendment) Regulations 2026.

Commencement.

2. These Regulations come into operation on 1 April 2026.
