IMPORTS AND EXPORTS ACT 1986

IMPORT DUTY (INTEGRATED TARIFF) (AMENDMENT) REGULATIONS 2010

In exercise of the powers conferred on it by sections 45 and 129 of the Imports and Exports Act 1986, the Government has made the following Regulations-

Title and commencement.

1. These Regulations may be cited as the Import Duty (Integrated Tariff) (Amendment) Regulations 2010.

Amendments to the Integrated Tariff.

- 2.(1) The Integrated Tariff as set out in Schedule 2 of the Import Duty (Integrated Tariff) Regulations 2003 ('the principal Regulations') is amended in accordance with the provisions of this regulation, with effect from 28th April 2010.
- (2) In Section IV, Chapter 24 of Schedule 2 to the principal Regulations, the tariff in respect of 2402.20.00 shall be as follows—

- (3) In Section IV, Chapter 24 of Schedule 2 to the principal Regulations, the tariff in Column 4 in respect of 2403.10.01, 2403.10.02, 2403.10.03, 2403.10.04, 2403.10.05, 2403.10.06, 2403.10.07, 2403.91.00, 2403.99.01, 2403.99.02 substitute, "£9.00 per kg + 5% av" with £19.23 per kg.
- (4) In Section V Chapter 27 of Schedule 2 to the principal Regulations, the tariff in Column 4 in respect of 2710.00.02 shall be increased to "29ppl".

- (5) In Section V, Chapter 27, of Schedule 2 to the principal Regulations, the tariff in Column 4 in respect of 2710.00.04 shall be increased to "15.5ppl".
- (6)(a) In Section IV, Chapter 22 of Schedule 2 to the principal Regulations, in Column 4 delete all references to "+5% AV".
 - (b) In Section IV, Chapter 22 of Schedule 2 to the principal Regulations, the tariff in Column 4 in respect of 2203.00.01 shall be increased to '32ppl'.
 - (c) In Section IV, Chapter 22 of Schedule 2 to the principal Regulations, the tariff in Column 4 in respect of 2203.00.02 shall be increased to '18ppl'.
 - (d) In Section IV, Chapter 22 of Schedule 2 to the principal Regulations, the tariff in Column 4 in respect of 2208.30.00, 2208.40.00, 2208.50.00, 2208.90.01, 2208.90.02, 2208.90.03, 2208.90.04 and 2208.90.06 shall be increased to '80ppl'.
