# **IMPORTS AND EXPORTS ACT, 1986**

### **INTEGRATED TARIFF (AMENDMENT NO.3) REGULATIONS 2020**

In exercise of the powers conferred on it by sections 45 and 129 of the Imports and Exports Act, 1986, and all other enabling powers, the Government has made the following Regulations-

#### Title.

1. These Regulations may be cited as the Integrated Tariff (Amendment No.3) Regulations 2020.

#### Commencement.

2. These Regulations are deemed to have come into operation on the 2<sup>nd</sup> July 2020.

# **Amendment of the Integrated Tariff Regulations 2017.**

- 3.(1) The Integrated Tariff Regulations 2017 are amended in accordance with this regulation.
