#### **INSOLVENCY ACT 2011**

## INSOLVENCY (CROSS BORDER INSOLVENCIES) (AMENDMENT) REGULATIONS 2015

In exercise of the powers conferred upon him by sections 495(2)(ii) and (iii) of the Insolvency Act 2011, the Minister has made the following regulations—

#### Title and commencement.

1. These Regulations may be cited as the Insolvency (Cross Border Insolvencies) (Amendment) Regulations 2015 and enter into force on the day of publication.

## Amendment of Insolvency (Cross Border Insolvencies) Regulations 2014.

2. The Insolvency (Cross Border Insolvencies) Regulations 2014 are amended in accordance with these Regulations.

#### Insertion of Regulation 34 and Schedule.

3. Insert the following after regulation 33—

### "Amendment of Insolvency (Cross Border Insolvencies) Regulations 2014.

34. A "designated foreign country" in the definition of "foreign proceeding" in regulation 2 is a country or territory that has been designated in the Schedule to these Regulations.
