1. These rules may be cited as the Limited Partnerships Rules.

### Fees.

2. The fees to be paid to the Registrar under the Ordinance shall be as follows—

	£
(a) On the original registration of a limited partnership	2.00
(b) On the registration of a statement of any change under section 8(1)	0.25
(c) For inspection of statements filed by the Registrar, for each inspection	0.05
(d) For a certificate of the registration of any limited partnership	0.13
(e) For a certified copy of or extract from any registered statement, for each folio of seventy-two words	0.03

### Forms.

3. The forms in the Schedule, with such variations as the circumstances of each case may require, shall be the forms to be used for the purposes of the Ordinance.
