LIMITED PARTNERSHIPS ACT 2021

LIMITED PARTNERSHIPS (FEES) (AMENDMENT) REGULATIONS 2025

In exercise of the powers conferred on him by section 41 of the Limited Partnerships Act 2021, the Minister has made the following Regulations—

Title.

1. These Regulations may be cited as the Limited Partnerships (Fees) (Amendment) Regulations 2025.

Commencement.

2. These Regulations come into operation on 1 August 2025.

Amendment of the Limited Partnerships (Fees) Regulations 2021.
