MERCHANT SHIPPING ACT

PILOTS (AMENDMENT) RULES 1987

In exercise of the powers conferred on him by Section 181 of the Merchant Shipping Act, and of all other enabling powers, the Governor has made the following rules:

Title.

1. These rules may be cited as the Pilots (Amendment) Rules 1987.

Amendment of Schedule 4.

2. Schedule 4 to the Pilots Rules is amended by revoking Part I thereof and substituting therefor the following:

"PART 1

BETWEEN THE HOURS OF 08.00 AND 18.00 ON ORDINARY WEEKDAYS.

SERVICE

1. When a vessel is brought to an anchorage berth or vice versa; warping from one berth to another, or shifting anchorage, or undergoing compass of D.F. adjustments or on trials or ranging-

2. When a vessel is brought to a berth alongside another vessel in the anchorage or to any berth alongside a quay, or vice versa:

As in paragraph 1, plus 50% subject to a minimum supplement of	£10.00

3. As in paragraph 1, plus 100%.

4. Attendance if delayed onboard one hour or more, for each hour of part thereof (if pilot is called only for attendance a minimum of two hours shall be charged) £10.00

5. Attendance if ordered to repair onboard by

Master or agent and service required	£15.00

6. Running lines by pilot boats £15 per boat.
