## PORT ACT

## PORT (AMENDMENT) RULES 2025

In exercise of the powers conferred on her by section 19 of the Port Act, the Minister has made the following Rules-

## Title.

1. These Rules may be cited as the Port (Amendment) Rules 2025.

## **Commencement.**

2. These Rules come into operation on 1<sup>st</sup> May 2025.

#### Amendment to the Port Rules.

- 3.(1) Schedule 4 to the Port Rules is amended in accordance with this rule.
- (2) For paragraph 1(a) substitute –

## "1. Tonnage dues.

(a) Subject to subparagraphs (b), (bb), (c) and (d), the following tonnage dues shall be payable by all vessels except passenger vessels, arriving at, touching at, or having communication with Gibraltar, or the anchorage, port or harbour thereof in respect of each period of forty eight hours or part thereof that a vessel remains at Gibraltar

- (4) After paragraph 1(b) insert
  - "(bb) In addition to the tonnage fees set out in subparagraph (a), the charges set by the Minister with responsibility for the Port and Shipping for the purpose of regulation 14 of the Gibraltar Merchant Shipping (Port Waste Reception Facilities) Regulations 2002 are payable by all vessels, arriving at, touching at or having communication with Gibraltar, or its anchorage, port or harbour;".
- (5) For paragraph 2 substitute –

## "2. Passenger ships: tonnage dues.

The following tonnage dues shall be payable by all passenger vessels arriving or touching at Gibraltar or the anchorage, port or harbour –

- (f) in subparagraph (f) for "3p" substitute "4p";
- (g) in subparagraph (h) for "6p" substitute "9p";
- (h) in subparagraph (j) for "8p" substitute "11p";
- (i) in subparagraph (k) for "3p" substitute "4p";
- (j) in subparagraph (l) for "6p" substitute "9p";
- (k) in subparagraph (m) for "8p" substitute "11p";
- (l) in the text below subparagraph (m) for "£5" substitute "£7.17".
- (8) In paragraph 10 (bunkering charges)-
  - (a) for "£0.20" substitute "£0.30";
  - (b) for the text below "Tonnage transferred" substitute -

"Less than 50,000 metric tonnes	£7,500
50,001-100,000 metric tonnes	£11,000
100,001-150,000 metric tonnes	£15,000
150,001-200,000 metric tonnes	£22,500";

- (c) in subparagraph (c), for "In additional" substitute "In addition".
- (9) In paragraph 14 (Super Yacht Tariff Card) for "£5/m" substitute "£6.50/m".
