**POST OFFICE ACT**

**COMMONWEALTH AND FOREIGN POST REGULATIONS  
(AMENDMENT) REGULATIONS 1999**

In exercise of the powers conferred on him by section 54 of the Post Office Act, and of all other enabling powers, the Governor has made the following regulations –

**Title and commencement.**

1. These Regulations may be cited as the Commonwealth and Foreign Post Regulations (Amendment) Regulations 1999, and shall come into operation on the 1st day of April 1999.

**Amendment to Schedule 1.**

2. Schedule 1 of the Commonwealth and Foreign Post Regulations (hereinafter called “the principal Regulations”) is amended by omitting items 1 and 2 and substituting therefor the following items –

“1. Letters including letter packets –

2. Postcards .28p”.
