PUBLIC FINANCE (CONTROL AND AUDIT) ACT

DRUG OFFENCES (PREVENTION AND ENFORCEMENT) FUND (AMENDMENT) (NO. 2) REGULATIONS 1995

In exercise of the powers conferred on him by section 19 of the Public Finance (Control and Audit) Act and of all other enabling powers, the Governor has made the following regulations -

1. Title and commencement.

These regulations may be cited as the Drug Offences (Prevention and Enforcement) (Amendment) Regulations 1995 and shall come into effect on the 27th day of March 1995.

2 Amendment to regulation 3.

Regulation 2 of the Drug Offences (Prevention and Enforcement) Fund Regulations 1992 (hereinafter called "the principal regulations") is amended by inserting after the figure "1988," the expression "the Drug Trafficking Offences Act 1995".

3. Amendment to regulation 4.

Regulation 4 of the principal regulations is amended --

- (a) in paragraph (e) by inserting after the figure "1986" the expression "or monies forfeit under section 44 or Part IV of the Drug Trafficking Offences Act 1995";
- (b) in paragraph (f) by inserting after the figure "1988" the expression "or the Drug Trafficking Offences Act 1995".

4. Amendment to regulation 5.

Regulation 5 of the principal Regulations is amended --

- (a) in paragraph (a) by inserting after the figure “1988” the expression “or under sections 17, 21, 22 or 23 of the Drug Trafficking Offences Act 1995”;
- (b) in paragraph (b) by--
 - (i) inserting in sub-paragraph (i) after the word “drugs” the words “or Scheduled Substances, as defined in the Drugs (Misuse) Act”;
 - (ii) omitting in sub-paragraph (ii) the figure “1986”;
 - (iii) inserting in sub-paragraph (iii) after the figure “1988” the expression “or the Drug Trafficking Act 1995”
- (c) by redesignating paragraph (c) as paragraph (d) and inserting between paragraph (b) and paragraph (d), as now so redesignated, the following new paragraph (c)--
 - “(c) any amount approved by the Controlling Officer to be used by a Government department or other organisation under the provisions of --
 - (i) Part IIIA and Schedule 5 of the Drugs (Misuse) Act;
 - (ii) Part III of the Drug Trafficking Offences Act 1995;”.

5. Amendment to Schedule.

The Schedule to the regulations is amended --

- (a) in the entry in respect of the Drugs (Misuse) Act, by inserting -
-

(i) after the figure "11" the figures

"11A
11B
11C
11D"

(ii) after the figure "17" the expression "Schedule 5";

- (b) after the entry in respect of the Drug Trafficking Offences Act 1988 by inserting the following new entry --

"Drug Trafficking Offences
Act 1995

and offences under regulations made under the Act."

6. Drug Offences (Prevention and Enforcement) Fund (Amendment) Regulations 1995.

For the avoidance of doubt, the Drug Offences (Prevention and Enforcement) Fund (Amendment) Regulations 1995 are of no effect.
