Title.

1. This notice may be cited as the Climate Action Fund (Establishment) Notice 2026.

Establishment of the Climate Action Fund.

2. I hereby give notice that in exercise of the powers conferred on me by section 18(3) of the Public Finance (Control and Audit) Act, I have established a special fund to be known as the Climate Action Fund for the purposes described in section 48 of the Climate Change Act 2019 and any regulations made thereunder.
