SOCIAL SECURITY (INSURANCE) ACT

**SOCIAL SECURITY (INSURANCE) (AMENDMENT OF
CONTRIBUTIONS) ORDER 2007**

In exercise of the powers conferred upon me by section 52 of the Social Security (Insurance) Act and with prior approval by resolution of the Gibraltar Parliament, I make the following Order—

Title and commencement.

1. This Order may be cited as the Social Security (Insurance) (Amendment of Contributions) Order 2007 and comes into operation on 1 April 2007.

Amendment of Schedule 1.

2. Schedule 1 to the Act is amended by omitting everything after the heading, and substituting the Schedule to this Order.

SCHEDULE

Combined Social Insurance and Other Contribution Rates

Rate of Contributions for an Employed Person

Employee - 10% of Gross Earnings

Subject to a maximum contribution of:

£269.75 for the period 1 April 2007 to 30 June 2007; and
£1,079.00 for the year ending June 2008 and each year thereafter;

Contributions are payable weekly subject to a minimum of £5.00 per week
and a maximum of £20.75 per week

Married Women*

£10.81 per week

* This rate only applies to those married women who prior to 1 January 1985
elected not to pay contributions to the Social Insurance Scheme.

Employer - 20% of Gross Earnings

Subject to a maximum contribution of:

£340.60 for the period 1 April 2007 to 30 June 2007; and
£1,362.40 for the year ending June 2008 and each year thereafter;

Contributions are payable weekly subject to a minimum of £15.00 per week
and a maximum of £26.20 per week

Rate of Contribution for a Self-Employed Person - 20% of Gross Earnings

Subject to a maximum contribution of:

£311.74 for the period 1 April 2007 to 30 June 2007; and
£1,246.96 for the year ending June 2008 and each year thereafter;

Contributions are payable weekly subject to a minimum of £10.00 per week and a maximum of £23.98 per week

Gibraltar Regiment

Employee Contributions

£12.12 per week

Employer Contributions

£16.33 per week

Apportionment of Contributions

All contributions collected with effect from 1 April 2007 shall be apportioned as follows:

Gibraltar Health Authority – GPMS	63.50%
Open Long-Term Benefits Fund	27.75%
Gibraltar Development Corporation – Training Levy	6.00%
Short-Term Benefits Fund	2.25%
Employment Injuries Insurance Fund	0.25%
Gibraltar Development Corporation – Insolvency Fund	0.25%
