SOCIAL SECURITY (INSURANCE) ACT (AMENDMENT) REGULATIONS 1996

In exercise of the powers conferred on me by section 53 of the Social Security (Insurance) Act, and of all other enabling powers, I have made the following regulations--

Title and Commencement.

1.(1) These regulations may be cited as the Social Security (Insurance) Act (Amendment) Regulations 1996.

(2) Except where otherwise specified in the regulation, these regulations shall take effect on the 1st day of October 1996.

Revocation of the Overlapping Benefits Regulations.

2. The Overlapping Benefits Regulations are hereby revoked.

Amendment to the Social Insurance (Benefits) Regulations.

3. The Social Insurance (Benefits) Regulations are amended by omitting the following regulations-

Regulations 3(2), 4(2) and (3), 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35 and 36.

4. Regulation 7 is amended by omitting sub-regulations (2), (3) and (4) and substituting therefore the following sub-regulation--

"(2) A person shall not, by reason of undergoing a period of imprisonment or detention in legal custody, be disqualified for receiving maternity grant or death grant.

(3) The payment to any person of any benefit--

- (a) which is excepted from the operation of paragraph (b) of section 23(1) of the Act by virtue of sub-regulation (2); or
- (b) which is payable otherwise than in respect of a period during which he is undergoing imprisonment or detention in legal custody,

shall be suspended while that person is undergoing imprisonment or detention in legal custody:

Provided that maternity grant, death grant and any other benefit to whom paragraph (b), of this sub-regulation applies may nevertheless be paid during any such period to any person appointed for the purpose by the Director to receive and deal with any sums payable on behalf of the beneficiary on account of that benefit, and the receipt of any person so appointed shall be a good discharge to the Director and the Fund for any sum so paid.".

5. Schedules 3, 4 and 6 of the Social Insurance (Benefits) Regulations are revoked.

Amendment to the Social Insurance (Claims and Payments) Regulations.

6. Regulation 2 of the Social Insurance (Claims and Payments) Regulations is amended-

- (a) by omitting the definition of "pension";
- (b) by omitting the definition of "pension order"

7. Regulation 4(2) is amended by omitting the words "widowed mother's allowance", "guardian's allowance" and "or to an increase of benefit".

8. Regulations 4(3), 6, 7(2), 8, 9 and 11(2) are omitted.

9. Schedule 1 of the Social Insurance (Claims and Payments) Regulations is revoked.

10. Schedule 2 of the Social Insurance (Claims and Payments) Regulations is amended by omitting the second entry commencing with the words "Pension" in column 1, "The period of six months" in column 2 and "Benefit in respect of any period" in column 3.
