# PARKING AND WAITING (AMENDMENT) (NO. 3) ORDER 1991.

In exercise of the powers conferred on me by section 94 .of the Traffic Act, I have made the following Order –

#### Title

1. This Order may be cited as the Parking and Waiting (Amendment) (No. 3) Order 1991.

#### Amendment to paragraph 8

- 2. Paragraph 8 of the Parking and Waiting Order (hereinafter called "the principal Order") is amended—
  - (a) in sub-paragraph (1) by—
    - (i) omitting the figure "(1)";
    - (ii) omitting the expression "24 hours" and substituting therefor the expression "14 days";
  - (b) by omitting sub-paragraph (2).

### Revocation and replacement of paragraph 17.

- 3. Paragraph 17 of the Parking and Waiting Order (hereinafter called. "the a principal Order") is revoked and replaced by the following new paragraph –
- "17 (1) No person shall wait with or park. any vehicle at any

where waiting is prohibited by any traffic sign, except for such time as is reasonably necessary to allow persons to board or alight from a motor vehicle or to board or unload luggage;

- (b) for a continuous period exceeding 14 days.
- (2) For the avoidance of doubt, where in exercise of his powers under section 86 (1) of the Act, the Commissioner of Police has placed a sign
  - (a) prohibiting parking;
  - (b) warning that vehicles in the vicinity of that sign are liable to be moved for contraventions of the Act; or
  - (c) warning that vehicles in that vicinity are liable to have- an immobilisation device affixed to them for contraventions of the Act,

any person shall be conclusively presumed to have seen such a sign within 24 hours of it having been so placed.".

#### Amendment to paragraph 18:

4. Paragraph 18 of the principal Order is amended by omitting the words "for the purpose of" and substituting therefor the words "when actually".

#### Amendment to Schedule 7.

5. Schedule 7 to the principal Order is amended by inserting after the entry in respect Cornwall's Parade the following new entry.

"Devil's Tower Road, 8:(10 a.m. to 7.00 p.m. outside No.18B on Mondays to Saturdays".

### Amendment to Schedule 10.

6. Schedule 10 to the principal Order is amended by inserting new entries as follows—

"Little Bay Car Park the area between the south east corner of

the Nuffield Pool boundary wall and the south east corner west of the lane leading from Camp Bay car park to Little Bay

Car Park.

Line Wall Road East side of Cloister Ramp to

35A Line Wall Road.".
