## **TRAFFIC ACT**

### **TRAFFIC (PARKING AND WAITING) ORDER (AMENDMENT) ORDER 2000**

In exercise of the powers conferred on him by section 92 and 104 of the Traffic Act, the Governor has made the following Order –

#### **Citation**

1. This Order may be cited as the Traffic (Parking and Waiting) Order (Amendment) Order 2000.

#### **Amendment to the Traffic (Parking and Waiting) Order**

2. The Traffic (Parking and Waiting) Order shall be amended by inserting after paragraph 12A the following paragraphs–

##### **“Parking in certain housing estates**

Areas to which paragraph 12B applies

12B.(1) This paragraph applies to the areas commonly known as–

- (a) Glacis Housing Estate;
- (b) Laguna Housing Estate;
- (c) Varyl Begg Housing Estate;
- (d) Edinburgh House Housing Estate;
- (e) St. Jago’s Housing Estate;
- (f) Schomberg Housing Estate;
- (g) Moorish Castle Housing Estate;
- (h) St. Joseph’s Housing Estate;

- (i) Catalan Bay Village,

and such other area as the Minister may designate by notice in the Gazette.

**Parking in areas to which paragraph 12B applies**

12C.(1) The Minister may demarcate parking spaces in any area to which paragraph 12B applies as well as spaces on which vehicles may not park.

- (2) A space demarcated under sub-paragraph (1) on which a vehicle may park may only be used—

- (a) by such persons as the Minister may authorise;
- (b) by such vehicles as the Minister may authorise; and

subject to such conditions as the Minister may see fit, including but not restricted to—

- (i) the payment of fees, and
- (ii) entering into a written licence agreement with the government.

- (3) A demarcation under sub-paragraph (1) shall consist of -

- (a) markings on the ground delineating the borders of the space, and
- (b) traffic signs erected in proximity to the demarcation.

(4) Traffic signs erected under sub-paragraph (3)(b) shall advertise the status of the area as a space on which vehicles may or may not park, as the case may be.

- a (5) Where the use of the parking space is subject to any condition, traffic sign erected under sub-paragraph (3)(b) shall advertise the existence of that condition.

(6) A person responsible for any act or omission contrary to subparagraph (2) shall be guilty of an offence.

(7) References in this paragraph and in paragraph 12B to the Minister are references to the Minister with responsibility for Transport.”.
