TRAFFIC ACT

TRAFFIC (CASEMATES SQUARE) REGULATIONS

In exercise of the powers conferred on him by section 92 and 104 of the Traffic Act, the Governor has made the following Regulations—

Citation and interpretation

- 1.(1) These Regulations may be cited as the Traffic (Casemates Square) Regulations.
- (2) In these Regulations-
 - "Casemates Square" means the hatched area in the plan set out in the Schedule comprising of the square bordered on the north side by the Grand Casemates building and Landport Gates, on the south side by the entrance to Main Street and the building known as the International Commercial Centre, on the west side by Casemates Gates, the building previously known as the Health Centre Building and Casemates Hill and on the east side by Casemates House: and a reference to "Casemates Square" shall not include a reference to Casemates Hill;
 - "permit" means a permit in writing issued by the Minister with responsibility for transport subject to such terms and conditions as the Minister may deem reasonable.

Parking and entry restrictions in Casemates Square

2. No person shall wait with or park any vehicle or leave any vehicle parked in Casemates Square without a permit.

Restrictions on driving

3. No person shall bring any vehicle into or drive or ride any vehicle in Casemates Square without a permit.

Ambulances, fire engines etc.

4. Nothing in regulation 2 and 3 shall apply to ambulances, fire engines, police vehicles or refuse-collection vehicles.

Consequential amendments

- 5.(1) The Control of Traffic Regulations is amended in Schedule 4 by deleting the following words—
 - "Engineer's Lane North to Casemates Square between the hours of 11 a.m. and 7 p.m. on all days except Sundays and Bank and Public Holidays, except for taxis and omnibuses proceeding South to Bedlam Court in Compliance with Regulation 6(3) of the Traffic (Main Street) Regulations, 1986".
- (2) The Traffic (Parking Fees) Notice is amended in the Schedule by deleting all references to "Casemates Square".
- (3) Traffic (Parking and Waiting) Order is amended in Schedule 4 (taxi stands), Schedule 5 (car parks) and Schedule 9 (parking places for disabled persons) by deleting all references to "Casemates Square".

Offences

6. A person responsible for any act or omission contrary to regulation 2 and 3 shall be guilty of an offence and shall be sentenced on summary conviction to a fine equivalent to level 1 on the standard scale.
