In exercise of the powers conferred on him by regulation 3 of the Traffic (Pedestrianisation) Regulations 2001, the Minister with responsibility for Transport has made the following Order—

#### Title.

1. This Order may be cited as the Traffic (Designation of Pedestrianised Areas) Order 2001.

### Bicycles and personal light electric transporters.

- 4.(1) No person may ride or park a bicycle or operate or park a personal light electric transporter in a Pedestrianised Area except as provided for in paragraph (2).
  - (2) Article 2(n), (h), (p) and (q) do not apply to bicycles or cargo bicycles that are ridden-
    - (a) along George's Lane towards Main Street and along Cathedral Square towards the junction with Secretary's Lane (by Fortress House);
    - (b) from the junction of Cathedral Square and Bomb House Lane, along Cathedral Square towards the junction with Secretary's Lane (by Fortress House); or
    - (c) from the junction by 17 John Mackintosh Square towards the junction of Irish Town and Mackintosh Square, to the junction of Irish Town and Cloister Ramp and exiting via Cloister Ramp.
