1.	Leaving a vehicle unattended and not drawn up to the right hand side of the road so as to permit the maximum clear passage for passing traffic.	Control of Traffic Regulations Regulation 8(a)
2.	Causing a vehicle or trailer to cause unnecessary obstruction of a road or obstruct the passage of traffic.	Regulation 17
3.	Stopping a vehicle or part thereof within the limits of a pedestrian crossing.	Regulation 50
4.	Parking a vehicle upon a footpath or at a place where parking is prohibited by traffic signs.	Traffic (Parking and Waiting) Order, Paragraph 3
5.	Waiting with or parking a vehicle at an appointed taxi stand.	Paragraph 7
6.	Parking a vehicle in a space reserved for essential service vehicles.	Paragraph 9, 9A, 10, 11,12, or 12A.
7.	Parking a motorcycle in a space demarcated for cars in a housing estate.	Paragraph 12 B(2).
