TRAFFIC ACT 2005

TRAFFIC (MISCELLANEOUS AMENDMENTS) REGULATIONS 2025

In exercise of the powers conferred on it by sections 76, 89, 91, 92 and 101 of the Traffic Act 2005 and all other enabling powers, the Government has made the following Regulations—

Title.

1. These Regulations may be cited as the Traffic (Miscellaneous Amendments) Regulations 2025.

Commencement.

2. These Regulations come into operation on the day of publication.

Amendment to the Traffic (Parking and Waiting) Regulations 2011.

- 3.(1) The Traffic (Parking and Waiting) Regulations 2011 are amended in accordance with this regulation.
- (2) In regulation 2-
 - (a) substitute the following for the definitions from "caravan" to "distinct zone"-

""caravan" means any structure designed or adapted for human habitation which is capable of being moved from one place to another whether by being towed or by being transported on a motor vehicle or trailer, and any motor vehicle whilst being used for human habitation;

"cycle lane" means part of a carriage way of a road reserved for bicycles and personal light electric transporters which is separate from the rest of the carriageway and is demarcated using traffic signs and road lines and markings;

- "distinct zone" means a street, district or housing estate or part thereof designated by Order pursuant to regulation 7;";
- (b) insert the following definition after the definition of "Red Zone"-

"Red Route Clearway" means a place designated by the Minister as a Red Route Clearway under regulation 28A;".

- (3) In regulation 3, delete every subregulation after subregulation (13).
- (4) Insert the following regulation, after regulation 7-

"Prohibitions in cycle lanes.

- 7A.(1) No person shall park a motor vehicle on a cycle lane.
- (2) no person shall wait in a motor vehicle on a cycle lane.".
- (5) Substitute the following for Regulation 18, subregulation (2)-
 - "(2) The parking fee prescribed under sub-regulation (1) shall be paid-
 - (a) into a ticket issuing machine relating to the Pay and Display zone in which the car is parked; or
 - (b) via an online payment portal approved by the Minister,

immediately upon the car being parked.".

- (6) In regulation 23-
 - (a) in subregulation (1), for "sub-regulation (2)" substitute "subregulation (2) and regulation 62"; and
 - (b) delete subregulation (2)(a).
- (7) In regulation 26-
 - (a) in subregulation (1), for "designate" substitute ", by means of traffic sign and paint on the road surface in accordance with subregulation (2), designate"; and
 - (b) in subregulation (2), for "by a" substitute "by signage and a".
- (8) In regulation 27, subregulation (3), for "level 1" substitute "level 2".
- (9) Delete regulation 28.
- (10) Insert the following regulations before regulation 29-

"Red Route Clearways.

28A.(1) The Minister may, by means of traffic sign, designate any place in Gibraltar to be a Red Route Clearway for the purposes of these Regulations.

- (2) A Red Route Clearway shall be demarcated by means of signage at both ends of the Red Route Clearway.
- (3) The Minister may cancel or vary any such designation made under subregulation (1).

Parking and Stopping in Red Route Clearways.

- 28B.(1) Subject to sub regulation (4), no person shall stop or park a vehicle in a Red Route Clearway.
- (2) In this Regulation, "stop" means temporary park, or to stop a vehicle to drop off or pick up any person or thing, or waiting, or any other type of stopping except in a line of traffic that has stopped immediately ahead or for any other reasons for the cause or need for which that vehicle or driver is not responsible.
- (3) A person who stops a vehicle contrary to sub regulation (1) commits an offence and shall be liable on summary conviction to a fine in the amount of level 2 on the standard scale.
- (4) The controls specified in sub regulation (1) do not apply in respect of a person
 - (a) causing a vehicle to stop in a Red Route Clearway if the vehicle is stopped in an area of the Red Route Clearway demarcated for such purpose;
 - (b) required by law to cause the vehicle to stop or not to proceed;
 - (c) obliged to stop the vehicle so as to avoid an accident;
 - (d) getting or giving help in consequence of an accident or an emergency, or otherwise taking action for public safety;
 - (e) opening or closing a gate or other barrier at the entrance to premises to which the vehicle is being driven or from which it has emerged if it is not reasonably practicable to cause the vehicle to stop elsewhere for the purpose;
 - (f) using the vehicle for fire brigade, ambulance or police purposes;
 - (g) using the vehicle in connection with the removal of any obstruction to traffic;
 - (h) using the vehicle in connection with the maintenance, improvement or reconstruction of any length of road forming part of or adjacent to a Red Route Clearway.

- (11) In regulation 29, in subregulation (1), for "Red Zone" substitute "Red Zone or Red Route Clearway.".
- (12) In Schedule 3, substitute the table with the following-

1. After the fourth permit, the fee for every subsequent permit, which shall be valid for up to three Vehicle Registration Numbers, will continue to be twice the fee of the permit it follows.	
Issue of Heavy Goods Vehicle Parking Permit (Fee)	£1800 per annum
Release of a vehicle that has been immobilised or removed (fee)	£80
Daily fee for detention of immobilised or removed vehicle	£15

Amendment to the Traffic (Pedestrianisation) Regulations 2001.

4.(1) The Traffic (Pedestrianisation) Regulations 2001 are amended in accordance with this regulation.

"

- (2) In regulation 5, in subregulation (2), for "these Regulations" substitute "this regulation".
- (3) Insert the following regulation after regulation 5-

"Offences: Riding in an unsafe manner.

- 5A.(1) A person who rides a bicycle or cargo bicycle or operates a personal light electric transporter in a manner that is unsafe to them or to other persons within a pedestrianised area commits an offence.
- (2) A person who commits an offence under this regulation shall be liable on summary conviction to a fine up to level 3 on the standard scale and may have any permit issued under these regulations suspended or revoked.".

Amendment to the Control of Traffic Regulations.

- 5.(1) The Control of Traffic Regulations are amended in accordance with this regulation.
- (2) In regulation 2, substitute the following for the definitions from "central reservation" to "personal light electric transporter"-
 - ""central reservation" means any provision made in a road, not being the provision of a street refuge, for dividing the road for the safety or guidance of vehicular traffic;
 - "crossing" means a crossing for foot-passengers established on any road;
 - "personal light electric transporter" has the meaning given in the Personal Light Electric Transporters Act 2023;".

(3) After regulation 2, substitute the following for "General Rules of the Road."-

"PART 1

General Rules of the Road.".

(4) After the revoked regulation 36, substitute the following for "Bicycles and personal light electric transporters."-

"PART 2

Bicycles and personal light electric transporters.".

(5) After regulation 42, substitute the following for "Cycle lanes."-

"PART 3

Cycle lanes.".

(6) Before regulation 43, substitute the following for "Speed Limits."-

"PART 4

Speed Limits.

(7) Substitute the following for the newly established Part 3-

"

PART 3

Cycle lanes

Interpretation.

- 42A. In this Part, unless the context otherwise requires-
- "contraflow cycle lane" means a single lane cycle lane which authorises persons travelling on a bicycle or personal light electric transporter to proceed in the opposite direction to the usual direction of traffic on that carriage way;
- "cycle lane" means part of a carriage way of a road reserved for bicycles and personal light electric transporters which is separate from the rest of the carriageway and is demarcated using traffic signs and road lines and markings.".

Cycle lanes.

42B.(1) A person travelling on a bicycle or personal light electric transporter on a cycle lane must do so in accordance with the traffic signs and road lines and markings used to demarcate that cycle lane.

(2) A person who fails to comply with the provisions of this regulation is guilty of an offence and is liable on summary conviction to a fine at level 3 on the standard scale.

Motor Vehicles in Cycle lanes.

- 42C.(1) No person shall, subject to subregulations (2), (3) and (4), drive a motor vehicle on a cycle lane.
- (2) Subregulation (1) does not apply to a motor vehicle being driven on a cycle lane-
 - (a) in order to pass a stationary vehicle;
 - (b) to enable the vehicle to enter, from the side of the road on which it is proceeding, land or premises adjacent to the length of the road on which the line is placed, or another road joining that road;
 - (c) due to circumstances outside the control of the driver;
 - (d) in order to avoid an accident; or
 - (e) for the purpose of complying with any direction of a traffic warden or a police officer in uniform.
- (3) When a vehicle is being used for at least one of the purposes mentioned in subregulation (4) and the observance of the prohibition in subregulation (1) would be likely to hinder the use of the vehicle for that purpose, then that prohibition does not apply to the driver of the vehicle.
- (4) The purposes referred to in subregulation (3) are purposes involving—
 - (a) the Fire and Rescue Service;
 - (b) an ambulance;
 - (c) bomb or explosive disposal; and
 - (d) the Royal Gibraltar Police.
- (5) A person who fails to comply with the provisions of this regulation is guilty of an offence and is liable on summary conviction to a fine at level 3 on the standard scale.

Contraflow cycle lanes.

42D.(1) Subject to subregulation (2), no person shall travel on a bicycle or a personal light electric transporter on a road containing a contraflow cycle lane other than on the demarcated contraflow cycle lane.

- (2) Subregulation (1) does not apply to a person travelling on a bicycle or a personal light electric transporter in the same direction as motor vehicular traffic.
- (3) A person who fails to comply with the provisions of this regulation is guilty of an offence and is liable on summary conviction to a fine at level 3 on the standard scale.".

Amendment to the Traffic (Fixed Penalty) Regulations 2011.

- 6.(1) The Traffic (Fixed Penalty) Regulations 2011 are amended in accordance with this regulation.
- (2) In Schedule 1-
 - (a) substitute the following paragraphs for paragraphs 6 to 7-
