TRANSPORT ACT 1998

TRANSPORT (AMENDMENT NO.3) REGULATIONS 2026

In exercise of the powers conferred on him by section 69 of the Transport Act 1998, and all other enabling powers, the Minister has made the following Regulations-

Title.

1. These Regulations may be cited as the Transport (Amendment No.3) Regulations 2026.

Commencement.

2. These Regulations come into operation on 1st August 2026.

Amendment to the Transport Regulations 2000.

- 3.(1) The Transport Regulations 2000 are amended in accordance with this regulation.

- (2) In regulation 107-

- (a) in subregulation (1), for “£51.50” substitute “£53.00”; and
- (b) in subregulation (6), for “£26.00” substitute “£26.50”.

- (3) In regulation 107A-

- (a) in subregulation (2), for “£20.50” substitute “£21.00”;
- (b) in subregulation (3), for “£10.50” substitute “£11.00”.
