 E_{NACTED} by the Legislature of Gibraltar.

Title.

1. This Ordinance may be cited as the Weapons of Mass Destruction (Amendment) Ordinance 2005.

Amendments to the Weapons of Mass Destruction Ordinance 2004.

- 2. The Weapons of Mass Destruction Ordinance 2004 is amended as follows—
 - (a) in section 2 by-
 - (i) substituting a semicolon for the full-stop at the end of the definition of "Supreme Court"; and
 - (ii) inserting the following definition after the definition of "Supreme Court—
 - ""toxin" means any toxin, whatever its origin or method of production.";
 - (b) in section 7, by inserting the words "which is" after the word and figure "section 3";
 - (c) in section 18(2) in paragraphs (b) and (c), by substituting the word "munition" for the word "munitions";
 - (d) in section 35, by inserting the following subsection after subsection (6)-
 - "(7) In this section, "approved equipment" and "samples" shall be construed in accordance with the Verification Annex.":
 - (e) in section 52–
 - (i) in subsection (1), by substituting the words "The following criteria shall be taken into account in considering whether a toxic chemical or precursor should be included in Schedule 1" for the words "No

toxic chemical or precursor shall be included in Schedule 1 without considering that"; and

- (ii) in subsection (3), by substituting the words "other Schedules" for the word and figures "Schedules 1, 2 or 3";
- (f) in Schedule 1, Part A (TOXIC CHEMICALS)-
 - (i) in paragraph 1, by substituting the symbol "(\leq C10" for the symbol "(\subseteq =C10";
 - (ii) in paragraph 2, by substituting the symbol "(\leq C10" for the symbol "(\subseteq =C10"; and
 - (iii) in paragraph 3, by substituting the symbol "(\leq C10" for the symbol "(\leq =C10".
